**INVITATION FOR BIDS**

**Construction of Poipet Wastewater Treatment Sub-project (Storm Drain)**

1. The Royal Government of Cambodia (RGC) represented by the Ministry of Economy and Finance has received a Loan and Grant from the Asian Development Bank (ADB) for GMS- Southern Economic Corridor Towns Development Project and intends to apply part of the Loan/Grant proceed to payments under Contract Ref. No.: PMU/MPWT/SECTDP/NCB/CW07 for the construction of Poipet Wastewater Treatment Sub-project (Storm Drain)
2. The Project Management Unit of MPWT now invites sealed bids from eligible and qualified bidders for the Contract No. PMU/MPWT/SECTDP/NCB/CW07, construction of 4 storm drain lines with the total length of about 2 km. The construction period is 15 months from date of notification to commence.
3. Procurement will be conducted through National Competitive Bidding Procedures outlined in the Procurement Manual for Externally Financed Projects/Programs, and under the laws and regulations governing public procurement within the Kingdom of Cambodia,
4. This invitation is open to all eligible bidders from eligible source countries as described in the Bidding Document.
5. Interested eligible bidders may obtain further information from and inspect the Bidding Documents at the address given below between 8:00 am – 11:30 am and 2:30 pm – 5:00 pm on all working days from **12 March 2018 to 11 April 2018**.
6. Interested bidders' attention is drawn to Sub Clause 6.3 of the Instructions to Bidders including:
  - The average annual volume of construction work of the successful bidder over the last three years (2014, 2015 & 2016) shall be US\$4.77 million
  - Shall demonstrate experience as prime contractor, or sub-contractor in the construction of at least two (2) works of a nature and complexity equivalent to the works within the last five years with contract value at least US\$2.40 million (To comply with this requirement, works cited should be at least 70 percent complete, billed and paid and Documentary evidence must be submitted with the bid.)
  - The minimum amount of liquid assets and/or credit facilities net of other contractual commitments of the successful bidder shall be at least US\$0.60 million
7. A complete set of bidding documents in English may be purchased by interested bidders on submission of a written application to **Mr. Pou Manith**, Procurement Officer, at PMU-Office Third Floor, Western Building, CNR Norodom Blvd, & St #106, Phnom Penh, Cambodia and upon payment of a non-refundable fee of **USD 150** or its equivalent in Cambodian Riel being **600,000 Riel**. The method of payment will be in cash or deposit to Bank account No.000000001333 of National Bank of Cambodia. The Bidding Documents may be collected in person or may be sent by email or courier, but the bidder has to deposit the fee at the above bank account and to pay for courier charge by his/her arrangement as appropriate at the discretion of bidder. Other than payment of the non-refundable fee specified above, there shall be no other conditions for the purchase of the bidding documents.

Bids will be opened in the presence of the bidders' representatives and other interested person who choose to attend in person at the address below at **10:00 a.m. (local time) on 11 April 2018**
10. The bid shall be accompanied by a **Bid Securing Declaration** as described in the Instruction to Bidders.
11. The Government of Cambodia and Asian Development Bank will respectively declare a firm ineligible either indefinitely or for a stated period of time, to be awarded a contract funded by the Government of Cambodia and/or Asian Development Bank, if it at any time it determines that the firm has engaged in corrupt or fraudulent, coercive or collusive practices in competing for or in executing a contract.
