Lot 1: Landfill Remediation in Stung Sen and Lot 2: Landfill Remediation in Serei Saophan

- The Government of Kingdom of Cambodia has received a loan from the Asian Development Bank towards the cost of Second Urban Environmental Management in the Tonle Sap Basin Project and it intends to apply part of the Grant proceed to payments under Contract for Ref. No.: PMU/MPWT/SUEMTSBBP-2/NCB/CW04 for the works, Lot 1: Landfill Remediation in Stung Sen and Lot 2: Landfill Remediation in Serei Saophan.
- The Ministry of Public Works and Transport now invites sealed bids from eligible and qualified bidders for the Contract No. PMU/MPWT/SUEMTSBBP-2/NCB/CW04. The construction period is Lot 1: eight (8) months and Lot 2: twelve (12) months from date of notification to commence. The Bidder evaluation and qualification criteria are included in Section II of the bidding document.
- Procurement will be conducted through National Competitive Bidding Procedures outlined in the Government's Standard Operating Procedures on Procurement for Externally Financed Projects/Programs.
- This invitation is open to all qualified bidders from eligible source countries of as described in the Bidding Document.
- Bidders attention is drawn to Sub-Clause 6.3 of the Instructions to Bidders (ITB) on the Qualification requirements. Qualification requirements include:
 - The average annual volume of construction work of the successful bidder over the last three years (2021, 2022 & 2023) shall be at least Lot 1: US\$ 1.77 million and Lot 2: **US\$ 2.48 million**.
 - The minimum amount of liquid assets and/or credit facilities net of other contractual commitments of the successful Bidder shall be at least Lot 1: US\$ 0.23 million and Lot 2: **US\$ 0.31 million**.
 - The bidder has substantially or successfully completed at least one similar contract as a prime contractor or as JV member or subcontractor where the share value of the works performed was at least the amount of **Lot 1: US\$ 0.47 million and Lot 2: US\$ 0.99 million** in the last five (5) years prior to the bid submission date. The similarity of the works experience shall be landfill remediation or landfill construction project.
 - For Cambodian Bidders: valid registration from the Ministry of Commerce (MOC), and Land Management Urban Planning and Construction (LMUPC) or Ministry of Public Works and Transport (MPWT), and a valid registration/permit /patent issued by the Ministry of Economy and Finance (MEF).
 - Bidders with duly audited financial statements by an independent audit firm, for the last three (3) years (2021, 2022 & 2023) demonstrating soundness of its financial position. As a minimum, the Bidder's net worth for the last three (3) years calculated as the difference between total assets and total liabilities should be positive. The financial statements and its audit should not violate the relevant national statutory accounting standards.
- The qualification criteria are more completely described in the Sub Clause 6.3 and 6.1(h) of the Instructions to Bidders in the Bidding Documents including essential equipment and key personnel.

The method of payment will be in cash or deposit (contact to us prior deposit) to Bank account No.0000000013535 of National Bank of Cambodia. The Bidding Documents may be collected in person, or may be sent by email or courier, at the discretion of the bidder, but the bidder has to deposit the fee at the above bank account and to pay for courier charge by his/her arrangement as appropriate. Other than payment of the non-refundable fee, there shall be no other conditions for the purchase of the bidding documents

- All bids shall be accompanied by a **Bid Securing Declaration** as described in the ITB.
- The Government and Asian Development Bank will respectively declare a firm ineligible either indefinitely or for a stated period of time, to be awarded a contract funded by them, if they at any time determine that the firm has engaged in fraud and corruption as described in ITB 3.
