Supply and Delivery of Landfill Equipment for Serei Saophoan Landfill

1. The Kingdom of Cambodia (RGC) represented by the Ministry of Economy and Finance has received a loan from the Asian Development Bank (ADB) toward the cost of Second Urban Environmental Management in the Tonle Sap Basin Project, and it intends to apply part of the proceeds of this loan to payments under the Contract for the Supply and Delivery of Landfill Equipment for Serei Saophoan Landfill, Contract No.: PMU/MPWT/TS-2/NCB/G02b.
2. The Ministry of Public Works and Transport now invites sealed bids from eligible and qualified bidders for the Supply and Delivery of Landfill Equipment for Serei Saophoan Landfill, Contract No.: PMU/MPWT/TS-2/NCB/G02b.
3. Procurement will be conducted through National Competitive Bidding Procedures specified in the RGC's Standard Operating Procedures on Procurement for All Externally Financed Projects/Program, under the laws and regulations governing public procurement within the Kingdom of Cambodia, and in accordance with the Financing Agreement and Procurement Regulations of ADB.
4. This invitation is open to all eligible bidders from eligible source countries as described in the Bidding Document.
5. Interested eligible bidders may obtain further information from **Mr. Pou Manith**, Procurement Officer, Ministry of Public Works and Transport; e-mail: poumanith@yahoo.com and inspect the Bidding Documents at the address given below (point 12) from 8:00 to 11:00 and 14:00 to 17:00 on working days.
6. Qualification requirements include:
 - The Bidder has satisfactorily completed at least one contract for supply of similar goods in the preceding three years of not less than US\$ 106,250.00.
 - The Bidder has completed contracts in the total cumulative amount equal to at least US\$ 637,500.00 in the preceding two years.
 - The Manufacturer of the offered goods, if a different entity from the Bidder, has experience of at least 3 years in the manufacturing of similar goods.
 - the Bidder has availability of liquid assets through either:
 - a) access to a line of credit or cash in bank account of an amount at least US\$ 212,500.00, net of other contractual commitments; or
 - b) credit terms with vendors specifically for the goods to be supplied under the contract, and valid for at least 6 months after the deadline date for submission of bids specified in ITB Clause 21.
7. A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written application to the address given below and

upon payment of a non-refundable fee of 50.00 US Dollars or its equivalent in Cambodian Riel being 200,000.00 Riels. The method of payment will be in cash or deposit to Bank account No.000000001333 of National Bank of Cambodia. The Bidding Documents may be collected in person or may be sent by email or courier, but the bidder has to deposit the fee at the above bank account and to pay for courier charge by his/her arrangement as appropriate at the discretion of the bidder. Other than payment of the non-refundable fee specified above, there shall be no other conditions for purchase of the bidding documents.
