1. The Kingdom of Cambodia has received financing from the Asian Development Bank (ADB) toward the cost of Livable Cities Investment Project. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The Ministry of Public Works and Transport (MPWT) (“the Employer”) invites sealed bids from eligible Bidders for the construction and completion of the following contract package (“the Works”).

3. Open competitive bidding – International advertisement will be conducted in accordance with ADB’s [Single-Stage: One Envelope](#) procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding.
  - (i) The Bidders’ net worth within last year shall be positive.
  - (ii) Minimum average annual construction turnover of **USD 26.73 million** calculated as total certified payments received for contracts in progress or completed, within the last five (5) years (2019, 2020, 2021, 2022 & 2023).
  - (iii) The Bidder must demonstrate that its financial resources defined in FIN - 3, less its financial obligations for its current contract commitments defined in FIN - 4, meet or exceed the total requirement for the Subject Contract of **USD 3.34 million**.
  - (iv) Participation as a contractor, Joint Venture partner, or Subcontractor in at least one contract or two contracts that have been satisfactorily and substantially completed within the last eight (8) years from 28 days prior to bid submission deadline and that are similar to the proposed works, where the value of the Bidder’s participation under:
    - one contract having experience in Treatment Plant, Sewer, Drainage, and Household Connection, where the value of the Bidder’s participation exceeds **USD 32.00 million; or**
    - two contracts: (i) Bidder’s participation under one contract having experience in Treatment Plant, Sewer, Drainage, and Household Connection exceeds **USD 17.00 million** and (ii). Experience in a road/irrigation construction project, where the contract value of the Bidder’s participation exceeds **USD 15.00 million**.
  - (v) Construction Experience in Key Activities

- Wastewater Treatment Plant, Capacity at least 5000 cu.m/day;
- Sewer minimum diameter 200mm (HDPE/U-PVC) at least 25.0 km;
- Storm Drainage any material, (at least 1.0 m diameter or a cross-section of 0.785 sq.m for other shape), at least 5.0 km; and
- Household/building connection at least 1000 households.

The qualification criteria are more completely described in the Bidding Document.

The Bidding Document may be collected in person, or may be sent by email or courier, at the discretion of the Bidder, but the Bidder has to deposit the fee at the above bank account and to pay for courier charge by his/her arrangement as appropriate. Other than payment of the non-refundable fee, there shall be no other conditions for the purchase of the bidding documents.
